Services are provided by our different departments: Refuge, Legal, Healthcare, Employment, Accommodation, and Family.

Other fields of action are awareness-raising amongst the local population with regard to the phenomenon of migration, and reporting situations of infringement of the rights of immigrants.

ASOCIACIÓN PRO DERECHOS HUMANOS DE ANDALUCÍA [ANDALUSIAN ASSOCIATION FOR HUMAN RIGHTS]

The Andalusian Association for Human Rights is a non-profit-making private association, based on the Universal Declaration of Human Rights proclaimed by the UN in 1948.

While Apdha's sphere of affiliation and direct area of activity is Andalusia, its activities can also reach a universal dimension on the grounds that Human Rights are the patrimony of humanity as a whole.

Our aim is specifically to demand the full validity of Human Rights as an instrument for raising awareness and transforming society. And we do not hesitate to act by reporting its failures or non-fulfilments with all the instruments available to us. Another of our objectives is to support the victims of human rights violations as far as possible, and to raise awareness about the principles concerned throughout Andalusian society.

The Apdha does not only defend Human Rights in an abstract way. We go further by focusing on the more disadvantaged sectors of society, excluded persons who suffer the most human rights violations.

Thus, our normal activity is divided up into work areas. In general, the Apdha addresses problems like social marginalization, immigration, shanty towns, racism and xenophobia, minors, prisons, peace and disarmament, education for peace and human rights, international solidarity, etc...

Similarly, the Apdha has run specific campaigns like "No más muertes en el Estrecho", (No more deaths in the Strait) "Papeles para todos y todas" ("ID papers for all"), "Manifiesto de las dos orillas" ("Manifiesto of the two shores"), "Acercamiento de presos a las cárceles andaluzas", ("Andalusian prisoners in Andalusian prisons") "Nadie elige ser pobre" ("No-one chooses to be poor")... From these areas documents, proposals and options on subjects related to the defence of human rights in very varied spheres are drawn up. And every two years the International Human Rights Conference is held.

The Apdha rests on two fundamental pillars – awareness-raising among the population and social denunciation. In order to achieve the objectives mentioned above, the Apdha is organised through various local offices. In total there are 11 offices located all over Andalusia: in Seville, Sierra Sur, Huelva, Bahía de Cádiz, Algeciras, Jerez de la Frontera, Córdoba, Málaga, Granada, Almería, and Ronda.

CEAR

The Comisión Española de Ayuda al Refugiado (Spanish Commission for Refugee Assistance) –CEAR– is a social, pluralistic and independent organisation, created in 1979. Its mission is to defend and promote Human Rights and the integral development of refugees, displaced persons, stateless persons and migrants in need of international protection and/or at risk from exclusion.

The CEAR is made up of organizations which defend human rights (Club de Amigos de la UNESCO [Friends of UNESCO Club], Asociación pro Derechos Humanos de España [Spanish Association for Human Rights], IEPALA), the main trade unions (UGT, CCOO, USO), religious organisations (Caritas Española, Iglesia Evangélica, Asociación Musulmana de España) and the main political parties with parliamentary representation (PP, PSOE, IU), as well as some important people renowned for their defence of the right to asylum and refugees' fundamental rights: D. Juan María Bandrés (currently honorary Chairman). D. Javier de Lucas is Chairman of the Commission and D. Alfredo Abad is General Secretary.

Since its founding, the CEAR has worked in the defence of refugees and their right to asylum (refugees being those who flee their countries due to well-founded fear of persecution for political, ethnic, religious reasons, for reasons of national origin, or due to belonging to a certain social group, due to generalised violence or armed conflict) and in the defence of victims of internal displacement (those who flee their homes for the same reasons but remain within their countries) and of those arriving in a situation of particular vulnerability or who are stateless.

While it does not exclude the possibility of working in or for other regions, the CEAR focuses its attention on countries and areas particularly affected by forced migrations; here the CEAR has a great deal of experience; e.g. in Colombia, the country of origin of the largest group of persons who have taken refuge in the Spanish State and the second country in the world in terms of numbers of internal displacements; the Maghreb and Western Africa, where the problem of movement to Europe is most highly concentrated due, to a great extent, to European migratory policies; and Palestine, a population with the greatest number of refugees in the world.

The CEAR also has a Foundation. The Fundación CEAR - Consejo de Apoyo a los Refugiados [“CEAR Foundation - Council for Support for Refugees”] continues the work which the Consejo de Apoyo a los Refugiados carried out between 1987 and 1992 on international cooperation, and is encouraged by the CEAR to act in countries and regions in conflict. All this time it has been working to foster global protection for refugees and displaced persons in regions and countries in conflict, and has accumulated over the last few years observable experience in the construction of human settlements for refugee or displaced populations in situations of extreme poverty, and has maintained a noticeable presence on the African continent and the Middle East.

- c. The creation of legal databases specialised in women’s rights,
- d. The analysis of teaching and research into gender and law.

The Centre on Human Rights in Conflict of the University of East London, UK (CHRC) is a centre which promotes interdisciplinary research, both academic and oriented towards the practical side, of use for drawing up international policy. Through such research, the CHRC aims to improve its understanding and management of the relationship between conflicts and human rights.

The main areas of interest for the CHRC are the study of human rights as causes and consequences of armed conflicts, the dilemma of pursuing justice and peace during and after conflict situations and the particular challenges which the participation of non-state actors such as illegal armed groups, multinational companies and terrorist organizations represent for the protection of human rights.

Amongst the CHRC’s recent projects, the most important are: Rule of Law in African Countries Emerging from Violent Conflict: Critical Issues and Cases (British Academy Large Grant); Building a Just and Durable Peace by Piece (European VII Framework Programme); Counter-terrorism and Human Rights in the European Union (Visiting Leverhulme Research Fellow).

ESCUELA DE CULTURA DE PAZ [SCHOOL FOR THE CULTURE OF PEACE]

The Escuela de Cultura de Paz of the Universidad Autónoma de Barcelona was founded in 1999 with the purpose of working for the culture of peace, human rights, the analysis of conflicts and peace processes, education for peace, disarmament and the prevention of armed conflicts.

The objectives of the School are:

- To promote understanding and the practice of the culture of peace.
- To research and take action regarding subjects related to conflict, peace processes, post-war rehabilitation, the arms trade, human rights, parallel diplomacy and education for peace.
- To train people so that they will be able to spread the message and practices of the culture of peace.

The Human Rights Programme of the School for the Culture of Peace of the Universidad Autónoma de Barcelona - which will be collaborating on HURI-AGE – monitors the international situation with regard to human rights and, in particular, monitors those questions which currently feature on the world agenda, like transitional justice.

Areas of analysis

- . Follow-up and analysis of transitional justice processes world-wide. Transitional justice is supposed to manage the delicate balance of the commitment to peace and the need for justice for the human rights abuses committed during a conflict or under a non-democratic regime.
- . Analysis and monitoring of the international situation regarding human rights based on the monitoring of over 30 sources of information, including intergovernmental organisations and NGOs, and designing specific indicators. This monitoring is performed in part through participation in the publications written by the Programa de Conflictos y Construcción de Paz (Programme on Conflict and Peacebuilding).

- Companies and Human Rights.

As a part of the Human Rights Programme, this question is monitored both on a national and an international level, with particular emphasis on the extractive industries.

Publications

- Boletín de Justicia Transicional. This journal contains news items concerning the processes undertaken by States which have suffered an armed conflict and aim to deal with past abuses and build peace.
- Derechos humanos en el Barómetro. This quarterly publication covers events occurring over the period concerned regarding human rights and transitional justice and includes a thematic analysis of one specific aspect considered to be of special importance during that quarter.
- Semáforo de Derechos Humanos. This monthly journal, in Spanish, contains all the news about human rights published in the Semáforo, written by the Programa de Conflictos y Construcción de Paz (Programme on Conflict and Peacebuilding).

The FMP's Strategic Lines are:

1. To foster, from the feminist perspective, Equal Opportunities and non-violence between men and women whatever their age, condition and origin, within the framework of the New Social Contract, helping to reconcile people's personal, family and professional lives.
2. To work towards the Social, Professional and Technological inclusion, from a gender-oriented perspective, of groups of the population at risk from exclusion, disadvantage or marginalisation of any kind.
3. To foster networking by the FMP itself and with the third sector in general, as well as collaboration with the public sectors and the different public administrations.
4. To foster a Corporate Social Responsibility of the Private and Business Sectors based on ethical values and premises, which permit the collaboration and development of the Own Resources Area of the FMP.
5. To carry out research, editing and publication from a gender-based perspective.
6. To consolidate the inclusion of Quality and the New Technologies (TIC) in the FMP's customary work.
7. To promote collaboration with the media.

Foro de Vida Independiente [Independent Living Forum]

The Independent Living Forum <http://forovidaindependiente.org/> is a citizens' group which fights for the Human Rights of people discriminated against due to their functional diversity (disability).

The Forum is organised exclusively through the Internet and develops and coordinates pro-rights activities by establishing communication and support mechanisms between equals

between the 800 people making up the group. This fight for rights is performed in various spheres including philosophy, bioethics, law, politics, social action, claims, etc.

The Independent Living Forum participated in the working group which analysed the impact of the international UN Convention on the Rights of Persons with Disabilities (functional diversity), run by the Bartolomé de las Casas Human Rights Institute of the Universidad Carlos III de Madrid and has written various analyses of laws affecting the group such as Ley 39/2006 de Promoción de la autonomía y atención a las personas en situación de dependencia (LEPA) [Act 39/2006 on Promotion of Personal Autonomy and Care for Dependent Persons], including an exhaustive analysis from the perspective of the Convention itself.

The Forum has also presented its opinions in different parliaments – both national and regional – as this is a group which talks in the first person about situations of dependence and discrimination on the grounds of functional diversity.

From the social action viewpoint, the Independent Living Forum supports the promotion of the concept of the personal assistant, mentioned in article 19 of the Convention and article 19 of the LEPA through Vida Independiente Offices like those in Madrid and Barcelona.

The Fundación O.N.C.E. para la Cooperación e Integración Social de Personas con Discapacidad [ONCE Foundation for Cooperation and the Social Integration of People with Disabilities], is a non-profit-making charity welfare organisation, of indefinite duration, which pursues social ends and which was set up by the ONCE (Organización Nacional de Ciegos Españoles) [Spanish National Organization of People with Impaired Eyesight] through Agreement 2E/88 of 28 January 1988 made by the General Board, for reasons of social solidarity with persons with disabilities in accordance with its Articles of Incorporation and By-laws.

The object or main purpose of the ONCE Foundation consists of running or promoting, either directly or through an agreement, social integration programmes and social services for people with disabilities. Of greatest importance are training and employment programmes, as well as global accessibility and the overcoming of barriers of all kinds.

The ONCE Foundation is a leading organisation in Europe in terms of job creation for people with disabilities, and in 2008 created 4,400 jobs, of which 90% were for people with disabilities. Similarly, the ONCE Foundation, in line with its objective of improving the quality of life of people with disabilities and their families, actively monitors their rights both on a national and a European level.

A MEETING PLACE

As well as the ONCE itself as the founding entity, the Board of Trustees of the Foundation (its highest organ of management) is made up of the main organizations for persons with disabilities in Spain. The CERMI (Comité Español de Representantes de Personas con Discapacidad) [Spanish Committee of Representatives of Persons with Disabilities], a platform uniting the main disabled people's organisations in Spain, also forms a part of the Board of Trustees of the ONCE Foundation. Similarly, the public administration is represented here at the highest level of the ONCE Foundation.

Set up as a platform which brings together the entire disability sector, the ONCE Foundation represents, increasingly actively, an example of the attitude, will and determination of a civil society structured around its representative organisations and which spares no efforts in its quest to improve the living conditions of certain groups and society in general.

The association has representation in nineteen countries in South America, Central America, the Caribbean, Mexico and Spain.

Over the last two years, the Latin American Network of Judges (REDLAJ), together with the Escuela Nacional de Magistrados ["National School of Judges"] (ENM) / Asociación de los Magistrados Brasileños ["Brazilian Association of Judges"] (AMB), the Universitat de Barcelona and the Universidad Autónoma de Chile, organised the first Congreso

- education and consciousness-raising: Survival produces material for educational centres and

the general public promoting the idea that indigenous peoples are as “modern” as us, and have the right to live on their own land in accordance with their beliefs.

- support and projects: Survival supports the projects of indigenous organisations and offers them a platform from which to address the world.
